Books in this vein, similar to Dorothy West's *The Living Is Easy*, frequently examine the lives of individuals, often women, whose choices and freedoms are constrained by their social and economic circumstances. They explore the performative nature of wealth and the often-unseen struggles behind opulent facades. These narratives typically delve into the compromises made for status and security.
