THE KNIGHT'S FATE: A TESTAMENT TO THE PRINCESS'S POWER

THE KNIGHT, THOUGH BRAVE AND WILLING TO FACE ANY DANGER FOR HIS BELOVED, IS ENTIRELY AT THE MERCY OF THE PRINCESS'S DECISION. THE LADY: THE ALLURE OF A NEW BEGINNING AND SOCIETAL EXPECTATIONS

THE LADY WAITING BEHIND THE OTHER DOOR SYMBOLIZES A DIFFERENT KIND OF FATE – A NEW LIFE, A SOCIETAL EXPECTATION OF MARRIAGE AND HAPPINESS. SHE REPRESENTS THE ALLURE OF A CONVENTIONAL PATH, A SANCTIONED UNION THAT WOULD BE SOCIALLY ACCEPTABLE FOR THE KNIGHT. HOWEVER, IN THE CONTEXT OF THE PRINCESS'S JEALOUSY, THIS "LADY" ALSO REPRESENTS A PERCEIVED BETRAYAL, A SOURCE OF POTENTIAL PAIN AND HUMILIATION. SHE IS THE ANTITHESIS OF DEATH BUT, FOR THE PRINCESS, POTENTIALLY A WORSE FATE.

THE LINGERING QUESTION: THE AMBIGUOUS ENDING OF "THE LADY OR THE TIGER?"
