BEYOND REACTIVE ENFORCEMENT, MANY LAW ENFORCEMENT AGENCIES ALSO ENGAGE IN PROACTIVE CRIME PREVENTION STRATEGIES, COMMUNITY POLICING INITIATIVES, AND EDUCATIONAL PROGRAMS AIMED AT DETERRING CRIMINAL BEHAVIOR. THE DISCRETION EXERCISED BY LAW ENFORCEMENT OFFICERS IN THEIR DAILY DUTIES IS A SIGNIFICANT ASPECT OF THE CRIMINAL JUSTICE PROCESS, IMPACTING WHO IS INVESTIGATED, ARRESTED, AND CHARGED.

THE JUDICIAL PROCESS: COURTS AND LEGAL PROCEEDINGS

THE COURTS ARE WHERE THE LEGAL GUILT OR INNOCENCE OF AN ACCUSED PERSON IS DETERMINED. THIS COMPONENT INCLUDES PROSECUTORS, DEFENSE ATTORNEYS, JUDGES, AND JURIES. DEFENSE ATTORNEYS, WHETHER PUBLIC DEFENDERS OR PRIVATE COUNSEL, REPRESENT THE ACCUSED, ENSURING THEIR RIGHTS ARE PROTECTED AND PRESENTING THEIR DEFENSE. JUDGES PRESIDE OVER COURT PROCEEDINGS, INTERPRET THE LAW, AND, IN SOME CASES, DETERMINE SENTENCES. THE JURY SYSTEM, A CORNERSTONE OF MANY LEGAL TRADITIONS, ALLOWS FOR A VERDICT TO BE REACHED BY A GROUP OF CITIZENS.

CORRECTIONS: PUNISHMENT, REHABILITATION, AND REENTRY

THE CORRECTIONS SYSTEM IS RESPONSIBLE FOR CARRYING OUT SENTENCES IMPOSED BY THE COURTS. THIS INCLUDES A RANGE OF SANCTIONS, FROM FINES AND PROBATION TO INCARCERATION IN JAILS AND PRISONS. THE GOALS OF CORRECTIONS ARE MULTIFACETED, ENCOMPASSING PUNISHMENT, DETERRENCE, INCAPACITATION, AND REHABILITATION. WHILE PUNISHMENT IS A PRIMARY OBJECTIVE, THERE IS A GROWING EMPHASIS ON REHABILITATION PROGRAMS DESIGNED TO HELP OFFENDERS ADDRESS THE UNDERLYING CAUSES OF THEIR CRIMINAL BEHAVIOR AND PREPARE FOR SUCCESSFUL REINTEGRATION INTO SOCIETY.

JAILS TYPICALLY HOLD INDIVIDUALS AWAITING TRIAL OR SERVING SHORT SENTENCES, WHILE PRISONS ARE FOR THOSE CONVICTED OF MORE SERIOUS OFFENSES AND SERVING LONGER TERMS. PROBATION AND PAROLE OFFER ALTERNATIVES TO INCARCERATION, ALLOWING OFFENDERS TO REMAIN IN THE COMMUNITY UNDER SUPERVISION. THE PROCESS OF REENTRY, HELPING INDIVIDUALS TRANSITION BACK INTO SOCIETY AFTER RELEASE FROM CORRECTIONAL FACILITIES, IS A CRITICAL BUT OFTEN CHALLENGING ASPECT OF THE CORRECTIONS SYSTEM, AIMING TO REDUCE RECIDIVISM.

THEORIES OF CRIMINAL JUSTICE

IN CONTRAST, THE POSITIVIST SCHOOL POSITS THAT CRIMINAL BEHAVIOR IS INFLUENCED BY BIOLOGICAL, PSYCHOLOGICAL, AND SOCIAL FACTORS BEYOND AN INDIVIDUAL'S CONTROL. THIS APPROACH OFTEN LEADS TO A FOCUS ON IDENTIFYING AND TREATING THE UNDERLYING CAUSES OF CRIME.

DETERRENCE THEORY AND INCAPACITATION

DETERRENCE THEORY SUGGESTS THAT THE THREAT OR APPLICATION OF PUNISHMENT CAN PREVENT FUTURE CRIMINAL ACTS. THIS CAN BE EITHER SPECIFIC DETERRENCE, AIMED AT PREVENTING AN INDIVIDUAL OFFENDER FROM RE-OFFENDING, OR GENERAL DETERRENCE, INTENDED TO DISSUADE THE BROADER POPULATION FROM ENGAGING IN CRIME. INCAPACITATION FOCUSES ON REMOVING OFFENDERS FROM SOCIETY THROUGH IMPRISONMENT, THEREBY PREVENTING THEM FROM COMMITTING FURTHER CRIMES DURING THEIR CONFINEMENT.

REHABILITATION AND RESTORATIVE JUSTICE

REHABILITATION AIMS TO REFORM OFFENDERS THROUGH PROGRAMS SUCH AS EDUCATION, VOCATIONAL TRAINING, AND THERAPY, WITH THE GOAL OF REDUCING RECIDIVISM. RESTORATIVE JUSTICE, A MORE RECENT APPROACH, FOCUSES ON REPAIRING THE HARM CAUSED BY CRIME BY BRINGING TOGETHER VICTIMS, OFFENDERS, AND COMMUNITY MEMBERS TO ADDRESS ACCOUNTABILITY AND PROMOTE HEALING. THIS MODEL EMPHASIZES MAKING AMENDS AND PREVENTING FUTURE HARM RATHER THAN SOLELY ON PUNISHMENT.
