EMPLOYING LOGICAL ARGUMENTS (LOGOS) AND CREDIBILITY (ETHOS)

WHILE EMOTIONAL APPEALS ARE CRUCIAL, A STRONG MONOLOGUE ALSO INCORPORATES LOGICAL REASONING AND ESTABLISHES THE SPEAKER'S CREDIBILITY. A BALANCED APPROACH THAT COMBINES EMOTIONAL DEPTH WITH RATIONAL JUSTIFICATION IS KEY TO INSPIRING MEANINGFUL ACTION.

STRUCTURING THE INVITATION TO A MARCH CAMILLA MONOLOGUE

OPENING HOOKS AND AUDIENCE ENGAGEMENT
