UNDERSTANDING THE FOUNDATIONS OF AMERICAN GOVERNMENT

THE ROLE OF THE SOCIAL CONTRACT

THE SOCIAL CONTRACT THEORY POSITS THAT INDIVIDUALS CONSENT TO SURRENDER SOME FREEDOMS TO A GOVERNMENT IN EXCHANGE FOR PROTECTION OF THEIR REMAINING RIGHTS. THIS IDEA UNDERPINS THE LEGITIMACY OF THE AMERICAN GOVERNMENT SYSTEM.

THE CONSTITUTION AND FEDERALISM

- NINETEENTH AMENDMENT – WOMEN'S SUFFRAGE

THE THREE BRANCHES OF GOVERNMENT

UNDERSTANDING THE LEGISLATIVE, EXECUTIVE, AND JUDICIAL BRANCHES IS FUNDAMENTAL TO GRASPING HOW AMERICAN GOVERNMENT OPERATES AND MAINTAINS CHECKS AND BALANCES.

THE LEGISLATIVE BRANCH

COMPOSED OF CONGRESS, WHICH INCLUDES THE HOUSE OF REPRESENTATIVES AND THE SENATE, THIS BRANCH IS RESPONSIBLE FOR CREATING LAWS. IT HOLDS POWERS SUCH AS BUDGETING, DECLARING WAR, AND OVERSIGHT OF THE EXECUTIVE.

THE EXECUTIVE BRANCH

HEADED BY THE PRESIDENT, THE EXECUTIVE BRANCH ENFORCES LAWS AND MANAGES FEDERAL AGENCIES. THE PRESIDENT ALSO HAS ROLES SUCH AS COMMANDER-IN-CHIEF AND CHIEF DIPLOMAT.

THE JUDICIAL BRANCH

THE SUPREME COURT AND LOWER FEDERAL COURTS INTERPRET LAWS AND ENSURE THEY COMPLY WITH THE CONSTITUTION. JUDICIAL REVIEW IS A KEY POWER ENABLING COURTS TO INVALIDATE UNCONSTITUTIONAL LAWS.

CIVIL LIBERTIES AND CIVIL RIGHTS

THIS SECTION ADDRESSES THE PROTECTIONS GUARANTEED TO INDIVIDUALS AND GROUPS, FOCUSING ON FREEDOMS AND EQUAL TREATMENT UNDER THE LAW.

CIVIL LIBERTIES OVERVIEW

CIVIL LIBERTIES ARE INDIVIDUAL FREEDOMS PROTECTED FROM GOVERNMENT INTERFERENCE, INCLUDING FREEDOM OF SPEECH, RELIGION, AND PRIVACY RIGHTS.

POLITICAL PARTICIPATION AND ELECTIONS
